ANNEX

Information on self-declared environmental claims according to ISO 14021:

Depending on the availability of a recycling infrastructure the requirements for a recyclability claim in accordance with ISO 14021 are fulfilled for the following countries:

Germany (DE)

For the following countries, recycling infrastructure is being developed for the tested packaging; there are currently no reliable findings on the degree of implementation.

Austria (AT), Italy (IT)

In general, claiming is not recommended if the recyclability is below 50 %.

Note: In some countries, small-format packaging is not sorted due to the fine screening technology used there (e.g. in Italy for packaging that is smaller than 65 mm in two dimensions). In these cases, the requirements for a recyclability claim in accordance with ISO 14021 are not met.
